When you decide to join our organization, please complete the enclosed application and return it with the application fee and proof of insurance (as required by membership category). If you have any questions, please contact Ashley Allen (636)332-5535.

We'll read & review your application at our next monthly meeting. Your attendance at this meeting is required. You'll be asked to speak about yourself and your work experience. Your application is read a second time at a meeting the following month, and the members in attendance vote on accepting your application. Again, attendance is required.

For the active membership category...After membership approval, a probationary period begins. The probationary period runs for 6 to 12 months, during which time you must attend all meetings and functions, and submit three (3) jobs to the Ethics Committee for your review before active membership is approved. This normally means attending one meeting each month. After successfully completing this requirement, you're considered an active member. As an active member, you'll have the full rights and responsibilities of membership as outlined in the Association's by-laws, including publication of your company name and address in the membership roster, which is printed each year in January.

ACTIVE: Any person engaged in the profession of arboriculture. Arboriculture being defined as planting, propagation, and preservation of trees and shrubs. Member must provide a Certificate of insurance verifying workman's compensation and property liability insurance of not less than \$100,000.00

ASSOCIATE: 1. Any person with an interest in the field of arboriculture.
2. Any person employed by an active member of the association not wanting power to vote nor to be able to hold elected office in the association.
3. Any person employed by a business related to the field of Arboriculture. (most not meet the qualifications of active membership).

PROBATIONARY: Temporary statues of any applicant for new membership as Active member, until review of jobs by Ethics Committee.

CONTRIBUTING: Supplier of Arborists' materials.

Municipal: Any person employed in an arboriculture position in a municipality.
